


GENDER AND DEVELOPMENT



MEMORANDUM CIRCULAR NO. 48 30 MAY 2013

Directing all concerned government agencies to adopt the gender equality guidelines in the development of their respective media policies and implementing programs in order to promote gender mainstreaming

Section 14, Article II of the 1987 Constitution

"State recognizes the role of women in nation-building

Ensure the fundamental equality before the law of women and men"

Section 24, Article II

"State recognizes the vital role of communication and information in nation-building"

Section 16, Chapter 4 of RA No. 9710"Magna Carta of Women"

"mandates the State to formulate policies and programs for the advancement of women in collaboration with government and non-government media-related organizations and to raise the consciousness of the general public in recognizing the dignity of women and the role and contribution of women in the family, community, and the society through the strategic use of mass media"

Section 36, Chapter VI of RA 9710

"all departments, including their attached agencies, offices, bureaus, state universities and colleges, government-owned and controlled corporations, local government units, and other government instrumentalities shall adopt gender mainstreaming as a strategy to promote women's human rights and eliminate gender discrimination in their systems, structures, policies, programs, processes and procedures"


SECTION 28 OF RA NO. 10352 (GENERAL APPROPRIATIONS ACT OF 2013)

• All agencies of the government shall formulate a Gender and Development (GAD) Plan designed to address gender issues within their concerned sectors or mandate and implement applicable provisions under RA No. 9710 and other laws, and that the GAD Plan shall be integrated in the regular activities of the agencies which shall be at least five percent (5%) of their <u>budgets</u>"

GAD Principles

- Equality between women and men is a key women's human right
- Participation in development is crucial to the empowerment of women and men
- Gender equality means promoting equal participation of women as agents of economic, social, and political change
- Achieving equality between women and men may involve the introduction of specific measures designed to eliminate gender inequalities and inequities
